ber 1, 1919, he was transferred to "C" Division (then Battleford, Saskatchewan), where he remained until his time expired on June 2, 1922. Larkins settled in Brandon, Manitoba, and became an active member of the Lions Club and the United Commercial Travelers.

LIBOIRON Reg. No. 15323, ex-S/Sgt. Charles Auguste Leo Liboiron, 56, died at Montreal, P.Q., on July 13, 1984. Born at Ponteix, Saskatchewan, on March 1, 1928, he joined the Force on August 25, 1947, at Regina as a recruit special constable and was immediately sent to "N" Division for part I training, then Depot Division on January 10, 1948, for part II training. On September 1, 1948, he was made a third-class constable, and in December of that year completed his recruit training and was posted to "K" Division. There he served at Lethbridge, Fort Macleod, Claresholm, Cardston and St. Paul Detachments. On November 6, 1950, he was transferred to "C" Division where he served at St. Jean, Hemmingford, Lacalle, Great Britain, Roberval and Dorval Detachments. In March of 1962 he was posted to Montreal C.I.B. Special Investigation and Counterfeit Section; in May of 1963 the Montreal C.I.B. Passport and Visa Fraud Section; in September of 1964 the Montreal C.I.B. N.C.I.U.; and in April of 1966 the Montreal C.I.B. Court Liaison Section. He was promoted to corporal on November 1, 1955; to sergeant on May 1, 1962; and to staff sergeant on November 1, 1967. S/Sgt. Liboiron retired from the Force on May 26, 1969.

MacLEAN Reg. No. 6299, ex-Sgt. Murdoch MacLean, 92, died June 29, 1984, at North Vancouver, B.C. Born August 22, 1892, at Scotsville, N.S., he joined the RNWMP at Vancouver on September 21, 1914, and was immediately stationed at Depot Division, where he served at Regina, Lanigan, Yorkton and Gretna, Saskatchewan, before being posted north to "B" Division, Dawson, Yukon Territory, on June 3, 1918. On November 1, 1919, he was returned to Depot Division, working at Regina and Kamsack Detachments until he purchased his discharge on September 11, 1920. He then served with the Saskatchewan Provincial Police until it was absorbed by the RCMP in May of 1928. On September 17, 1931, he rejoined the Force at Edmonton. Stationed at Depot Division, he served at Regina, Saskatoon, Rosetown, Young and Biggar Detachments; and when the area was redesignated "F" division, Regina Town Station; then Regina Sub-Division, as section NCO. He was promoted to lance corporal on August 1, 1936; to corporal on August 1, 1937; and sergeant on May 1, 1952. Sgt. MacLean retired on October 23, 1945.

MAZURKEWICH Reg. No. C/1216, C/M Peter Mazurkewich, 55, died May 23, 1984, at Saskatoon, Saskatchewan. Born February 2, 1929, at Colonsay, Sask., he joined the RCMP on September 25, 1972, at Regina, Sask., as an identification technician in the Regina Crime Index Section. In August of 1973 he was posted to Saskatoon as a telecommunications operator, a position he maintained until his death.

McLATCHIE Reg. No. 12724, ex-Sqt. Wilfrid Ellsworth McLatchie, 69, died at Chilliwack, B.C. on September 1, 1982. Born July 8, 1913, at Montreal, P.Q., he joined the Force on July 8, 1935, at Ottawa. After his recruit training at Depot Division he was posted to "F" Division, where he served at Regina Town Station, Moosomin, Swift Current and Broadview Detachments before being transferred, in July of 1940, to "E" Division. There, in British Columbia, he was stationed at Vancouver, Abbotsford, Vernon, Prince Rupert, Grand Forks, Victoria, Mission, and Chilliwack. He was promoted to corporal on January 1, 1951, and to sergeant on November 1, 1957; and retired from the Force on July 7, 1961. He had been awarded the RCMP L.S.M.; bronze clasp and star.

**McNEIL** Reg. No. S/8307, ex-S/Cst. Kenneth Manual McNeil, 75, died on April 5, 1984, at Cranbrook, B.C.

MEAD Reg. No. 13035, ex-Cpl. John Edward Mead, 66, died July 21, 1984, at Calgary, Alberta. Born August 24, 1917, at Bellevue, Alberta, he first joined the Force as a special constable (clerk) on April 1, 1938, at Montreal, P.Q., and was assigned duty in the Central Registry at Headquarters; on strength to "A" Division. On April 6th he was transferred to the "N" Division Orderly Room until January 9, 1939, when he was transferred to Depot for recruit training (he had become a regular member, 3rd class constable, after his 21st birthday, on October 1, 1938). On June 29, 1939, he was posted to "O" Division, where he worked at Toronto Town Station, Guelph, Sudbury and Windsor Detachments, before being moved to "E" Division in November of 1940 to work with the Drug Squad of Vancouver C.I.B. In October of 1946 he was posted to neighbouring "K" Division where he was stationed at Cadomin, Jasper, Edmonton, Wetaskawin, Stettler, Rocky Mountain House, and Stony Plain Detachments. His last posting was "K" Division HQ C.I.B. Central Registry, Edmonton. He was promoted to corporal November 1, 1947; and retired on July 18, 1958. Ex-Cpl. Mead became a member of the RCMP Veterans Assoc., Calgary Division, in 1983.

MILES Reg. No. 13353, ex-Cst. Albert William Miles, 68, died July 5, 1984, at Edmonton, Alberta. Born at Truro, Nova Scotia on January 5, 1916, he joined the RCMP at Halifax on April 8,
