The following Petition was brought up and laid on the Table :

By the Honorable Mr. *Wilmot*; of the Rector, Church Wardens and Vestry of *St. Jude's Church*, in the Parish of *Victoria*, City of *St. John, New Brunswick*.

Pursuant to the Order of the Day, the following petition was read :

Of the *London Board of Trade*; praying that in any legislation on the subject of *Banking*, no change of a fundamental character may be made in the present system, and that the circulation of the Banks may be preserved on its present basis.

The Committee on Standing Orders and Private Bills have the honor to present the following as their Twelfth Report :

Your Committee have examined the Petition of the *Ontario Bank*, praying for an Act to continue their charter and to grant power to their Directors to change the Head Office or chief place of business to such place in the Province of *Quebec* or *Ontario*, as they may determine, with the sanction of the majority of the shareholders, and find that sufficient notice had been given.

Your Committee have examined the Petition of the *British America Assurance Company*, praying for the Amendment of their Act of Incorporation and find that no notice has been given. Your Committee, however, recommend the suspension of the 51st Rule in this case, as it will be competent for them as Committee on Private Bills to provide that no injury to any party shall arise therefrom.
