In this proportion, in a stomachful, whether of woman's milk or of cow's milk the casein is nearly equal. A moment's thought though will show that the other solids—butter, albumen, sugar of milk, etc., in the stomachful of diluted cow's milk, are over 50% less than in the same quantity of woman's milk, which readily explains why so many infants fed on diluted cow's milk gradually fade and pine away, actually starved to death. Moreover in all cities the adulteration of cow's milk is notorious, and to it are traceable many cases of typhoid, diphtheria, and incipient consumption, to say nothing of the universal practice of feeding the cows, in the neighborhood of large cities, on brewer's grains, distillery mash, and city garbage.

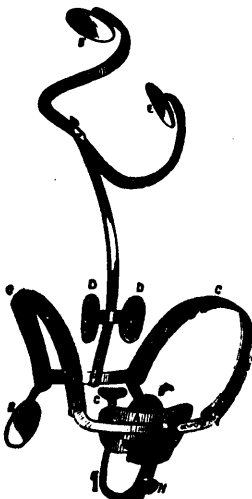
Fig. No. 8 is a comfortable support to the abdomen, but is not so effective as No. 8 in supporting the bowels, spine or chest.

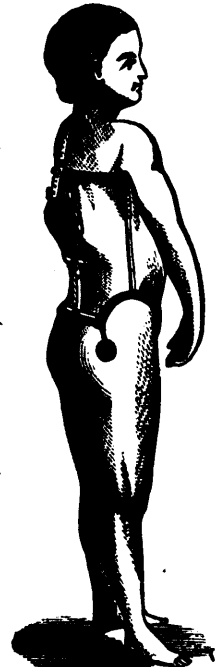

HOW TO MEASURE FOR ANY OF THESE APPLIANCES
1st. Around the body, two inches below the tip of hip bones.
2nd. Around the chest, close under the arms.

3rd. From each armpit to corresponding tip of hip bone.
4th. Height of person. All measures to be in inches.
Measure over the linen, drawing the measure moderately tight.
