# PUBLIC ACCOUNTS

INQUIRY AS TO PRINTING AND DISTRIBUTION

A single copy was tabled on November 12, but I am advised that the printed copies are not yet available, though under the statute we were supposed to have had them some two months ago. Can the minister advise when they will be available, and could they be distributed to hon. members even though we have left Ottawa, so we shall not have to wait until next session in order to have them?

Hon. J. L. ILSLEY (Minister of Finance): I will make inquiries and let the hon. gentleman know later to-day when they will be printed. As a matter of fact I had lost touch with the matter; I assumed they would be printed and tabled before this. It would be a great pity to have to mail them, because they are so bulky, I will find out to-day how the matter stands and let the hon. gentleman know before the house prorogues.

Mr. ILSLEY: If the leader of the opposition will allow me to state this in committee, he asked a question while the Speaker was in the chair in regard to the public accounts. I have made inquiry, and I am told that the public accounts will not be ready before another month. They will be mailed, however, or expressed to all hon. members of the House of Commons as soon as they are published. The reason for the delay is that we have superannuated a number of employees

at the printing bureau who have not been replaced; the session came on, with all the printing tasks which it involved; we have had various royal commissions, and it has been impossible to have this work done.
