PLANT NOISE ABATEMENT ACT

MEASURE SETTING OUT MAXIMUM NOISE LEVELS

Mr. Barry Mather (Surrey) moved for leave to introduce Bill C-199, respecting noise in factories.

Some hon. Members: Explain.

Mr. Mather: Mr. Speaker, the purpose of this bill is to combat a major health hazard in industry by requiring that the noise levels in establishments having contracts with the government of Canada shall be at a maximum of 85 decibels. The noise level at 85 decibels is said by health experts to be such that one can hardly hear oneself talk. I might point out that similar legislation to this was enacted earlier this week in the United States and is now law in that country.

Mr. John L. Skoberg (Moose Jaw): Thank you, Mr. Speaker. I wish to rise on a question of privilege having to do with the failure of the government to respond to my appeals for a public inquiry into the alarming series of railway mishaps.

I originally brought the matter of rail safety and mishaps to the attention of the minister of transport on January 8, and to date there has not been any action on the part of the government to initiate or establish a public inquiry into the increasing number of mishaps on the railways. As a member of parliament who has some experience in railway operations, and inasmuch as I have been attempting, without avail, to have a public inquiry conducted, and particularly in view of the collision last night in which two members of a crew lost their lives and many passengers were injured, could I not, through you, Mr. Speaker, implore the government immediately to set up a public inquiry with terms of reference broad enough to conduct a meaningful investigation into the causes of such mishaps, and the safety of all rail operations?

Mr. Speaker: Perhaps it should not be necessary for the Chair to make a ruling on the point raised by the hon. member. He suspects, I would think, that this is not really a question of privilege. The hon. member has at most a grievance, perhaps a question that he might want to pose during the question period. I would not think there was a true question of privilege in any event since no motion was proposed by the hon, member, I suggest we go on to the business of the house at this time in our proceedings, which is that of oral questions.
