## SUGGESTIONS FOR SUMMER EMPLOYMENT OF YOUTH

In working out the government's \$50 million program for providing employment for our youth this summer, is the government giving consideration to employment in reforestation, cleaning up our salmon spawning beds and other waterways and partially subsidizing the wage cost of employment on farms, as well as other healthy and useful work, so that our young people may be constructively employed in work that is useful to the economy?

**Hon. Otto E. Lang (Minister of Manpower and Immigration):** Mr. Speaker, without accepting the premise of the hon. member's question, the work which is being done on the question of student unemployment involves an examination of all ideas which come forward and seem to be reasonable. I previously made it clear to hon. members that I welcome their suggestions whenever they seem to have an air of reason about them.

**Mr. Hees:** In considering constructive jobs that will or might be available for young people this summer, does the minister consider that there will be sufficient of this kind of work available so that it will not be necessary to send our unemployed youth throughout the country on free bus tours as is presently planned by the government?
