I should also like to ask him whether he has further information as to whether General Dare, Colonel Sutherland and the others who are working directly on this project have also engaged the services of people outside the public service, members of the university staffs, and so on, to do some of the studies? Would the Prime Minister at some point make a statement to the House as to the reason for the expenditures for these studies?

Mr. Trudeau: I believe I can answer part of the question right now. I have found the memo indicating the names of the people who are seconded to General Dare and are on loan from various agencies. There is Colonel Sutherland, on loan from the Department of National Defence; Mr. White, on loan from the Emergency Measures Organization; Mr. Blackwell, on loan from the Emergency Measures Organizations, and Mr. Woodend on loan from the Defence Research Board. Two people have been retained on contracts for specific studies, namely Professor Jackson and Professor Van Loon.

As to the other part of the question, I believe the hon. member will see from the terms of reference the reasons they are working on these projects and what their terms of reference are.

Mr. Lewis: Could the Prime Minister inform the House whether the expenditures for this exercise come out of the Privy Council office or the Prime Minister's office? Precisely under what umbrella are these expenditures being made?

Mr. Trudeau: I believe the expenditures come from the Privy Council office. If that is not correct, I will report to the House, but I am almost certain that it is so.

Mr. Woolliams: Perhaps my hon. friend over there needs a psychiatrist. Is a report demanded from a psychiatrist indicating that the person is now rehabilitated and it is now safe to release him into society?

Mr. Speaker: If the minister replies to the question, I hope he will be brief because the first part of the question asked by the hon. member for Calgary North would appear to invite a rather lengthy statement. However, the minister will be recognized for the purpose of replying briefly to the hon. member's question.
