#### INDIAN AFFAIRS AND NORTHERN DEVELOPMENT— AMENDMENT TO BILL 13-47

## Question No. 2,627-Mr. Orlikow:

- 1. Is the Minister of Indian Affairs and Northern Development aware of the amendment by the Council of the Northwest Territories to Bill 13-47 "An ordinance Respecting the Preservation of Game" enacted on June 30, 1972?
- 2. Has the Minister received a request from the Inuit Tapirisat of Canada requesting him to disallow that amendment because no opportunity was given to the native organizations to submit their recommendations or to make clear the difficulties this amendment will cause to native people?
- 3. Has the Minister made a decision regarding this request, and, if so (a) what was it (b) for what reasons?

# Hon. Jean Chrétien (Minister of Indian Affairs and Northern Development): 1. Yes.

- 2. Yes. The Minister received a letter from the President of Inuit Tapirisat, Mr. Tagak E. C. Curley dated June 5, 1973.
- 3. The Minister carefully studied both the amendments to the Bill and the arguments presented in the brief and concluded that the amended Ordinance will not result in the dilution of native hunting rights. Commissioner Hodgson is currently in the process of conducting a comprehensive review of all aspects of the Game Ordinance and Inuit Tapirisat (through the Federation of Natives North of 60°) as well as the other native organizations have been invited to assist Territorial officials in this review.

### BOWDEN CORRECTIONAL CENTRE, ALBERTA

### Question No. 2,628-Mr. Gleave:

- 1. On what date was the Bowden Correctional Centre in the province of Alberta purchased by the government?
- 2. What price was paid for this property?
- 3. What understanding was given as to continued employment of personnel at the institution?
- 4. How many inmates will the institution accommodate?

Hon. Warren Allmand (Solicitor General): 1. Negotiations for purchase of the Bowden Correctional Centre are not yet completed.

- 2. No money paid to date.
- 3. Negotiations now in progress aim at the hiring of all the present staff of Bowden with the possible exception of a very small number whose categories of employment are not normally required in the operational system of the Canadian Penitentiary Service. However, the operation of Bowden as a medium security institution of the Canadian Penitentiary Service will require a larger staff than presently employed there.
  - 4. Approximately 200.
