PETROLEUM INDUSTRY

Question No. 250—Mr. Herbert:

1. What percentage of the shareholding of (a) Imperial Oil (b) Shell Canada (c) Gulf Canada (d) Texaco Canada, is believed to be owned by Canadians?
2. In each of the past five years, what was the combined (a) profit after taxes (b) dividends distributed (c) taxes and royalties paid to the (i) government (ii) provincial governments?

Mr. D. M. Collette (Parliamentary Secretary to President of the Privy Council): I am informed by the Department of Energy, Mines and Resources and Statistics Canada as follows: 1. Statistics Canada reports that in 1979, the latest year for which information is available under the Corporations and Labour Unions Returns Act, the degree of Canadian ownership was as follows:

(a) Imperial Oil	22.33 per cent.
(b) Shell Canada	25.92 per cent.
(c) Gulf Canada	26.13 per cent.
(d) Texaco Canada	9.10 per cent.
