### REQUEST THAT GOVERNMENT ACT TO REVITALIZE INDUSTRY

Hon. Don Mazankowski (Vegreville): Madam Speaker, since the minister believes that the tax treatment under the National Energy Program does not have a major impact, what is he prepared to do to revitalize the petrochemical industry in order to fulfil the commitment he made in October, 1980, under the National Energy Program, when he said that he would be concentrating on the future growth of the petrochemical industry in western Canada, principally in Alberta? He said he hoped this would begin a new era of western diversity. Surely it is because of the National Energy Program that in large part the petrochemical industry is in danger. What is the minister proposing to do to revitalize that very important sector and thereby create jobs for Canadians?

Hon. Marc Lalonde (Minister of Energy, Mines and Resources): Madam Speaker, I am afraid that once again my hon. friend has not understood my first answer. There is no National Energy Program in the United States, Japan or Europe, and their petrochemical industry is going through extreme difficulties at the present time, in fact difficulties that are more severe than those being encountered at the present time by the Canadian industry. As I indicated, there is a task force set up under the Department of Regional Industrial Expansion which, at the present time, is examining the whole situation of the petrochemical industry.

Our interest is to have a very bright, vibrant and dynamic petrochemical industry in this country. However, as long as the world is going through the recession that we are going through, there is no point in trying to sell products to people who do not buy. The demand for petrochemicals is down all over the world. What we have to fight for and support are the types of measures that the government has announced to get the Canadian economy on the road to recovery. We hope other economies of the world will follow the same steps.
