#### **CRIMINAL CODE**

AMENDMENT TO REINSTATE DEATH SENTENCE

Mr. Gordon Taylor (Bow River) moved for leave to introduce Bill C-206, an Act to amend the Criminal Code (death sentence).

Mr. Speaker: Is it the pleasure of the House that the Hon. Member shall have leave to introduce the Bill?

Mr. Taylor: Mr. Speaker, I take great pleasure in introducing a Bill to amend the Criminal Code with respect to the death sentence. This Bill, when passed, will impose the death sentence on any adult who deliberately plans and kills another

human being and is found guilty of so doing beyond a reasonable doubt.

REFERENCE OF ANNUAL REPORTS TO STANDING COMMITTEE

Hon. Ray Hnatyshyn (Minister of State (Government House Leader)): Mr. Speaker, there have been consultations among House Leaders of each of the Parties. I believe you will find that there will be a disposition to accept unanimously the following motion:

That the Standing Committee on Justice and Legal Affairs shall have permanently referred to it all annual reports made to Parliament pursuant to section 72 of the Privacy Act and section 72 of the Access to Information Act; and

That it be an instruction to the Standing Committee on Justice and Legal Affairs to:

- Consider every report prepared under section 72 of the Access to Information Act and of the Privacy Act;
- Undertake, on a permanent basis, a review pursuant to subsection 75(1) of the Access to Information Act and of the Privacy Act, of the administration of those Acts; and
- Undertake, within three years of their coming into force, a comprehensive review of the provisions and operation of the Access to Information Act and of the Privacy Act pursuant to subsection 75(2) of each of the said Acts.

Mr. Speaker: The House has heard the motion. Is there unanimous consent for its introduction?
