CONSTRUCTION OF PRISON IN PORT-CARTIER—CANCELLATION OF OTHER CAPITAL PROJECTS

Mr. John Nunziata (York South—Weston): Mr. Speaker, my question concerns the Prime Minister's misguided exercise in pork-barrel politics, that is, his \$68 million prison in his own

According to information I received yesterday from Correctional Services Canada the Government has cancelled 25 much needed capital projects in the correctional services.
