## Government Orders

If after the election, if by some quirk of fate, that this government happens to be successful, I fear that it will continue the program of dismantling the structures which have made Canada what it is today.

There is a change also proposed in the base year of the payments. This could be another way to allow the government more manoeuvrability in an election year.

Another issue in the proposed legislation is that the government is still trying to coerce the provinces into harmonizing the goods and services tax with the provincial sales tax thereby broadening the tax base for Canadians.

I plead with the government that it not try to move this down the road for its own means, that it will be serious and that it will make sure that the transfers and the equalization payments are maintained and increased in this country. There are still many jurisdictions out there that are going to need the help of the central government and the other more affluent provinces for a long time to come.

I urge this government to be prepared to continue this, to improve it, not to stop it in the two years down the road and not to dismantle it.
