Reported amended, 214. Considered and progress reported, 246. Again considered, amended, reported, and agreed to, 256. Order for third reading discharged,—Bill re-committed, amended, reported, and agreed to, motion for third reading. Amendments negatived:—By Mr. *Bowell*, 265. By Mr. *Bourassa*, 266. By Messrs. *Mitchell*, *Colby*, *Béchar*d and *Colby*, 267. By Mr. *Palmer*, 268. By Messrs. *Metcalf*e, *Thompson* (Cariboo) and *Mousseau*, 269. Bill again recommitted on motion of Mr. *Goudge*, amended, reported, agreed to, read third time and passed, 269.
