Ordered, That the said Report and Papers do lie on the Table.

Then, on motion of the Honorable Mr. Botsford, seconded by the Honorable Mr.

Letellier de St. Just, it was

Ordered, That the said Report of His Honor the Speaker and the papers connected therewith be referred to a Select Committee composed of the Honorable Messieurs Scott, Campbell, Bureau, Haviland, Miller, Seymour and the mover, with instructions to have such portions as they may think proper printed for the use of Members.

A Message was brought from the House of Commons by their Clerk in the following words:

House of Commons,

Monday, 14th February, 1876.

Resolved, That a Message be sent to the Senate informing their Honors that this House has appointed the Hon. Mr. Mackenzie, Right Hon. Sir John A. Macdonald, Hon. Messrs. Cameron (Cardwell), Cartwright, Cauchon, Cameron (Ontario), Holton and Tupper, Messrs. Fréchette, Delorme, Mills, Young, Laurier, Brouse, Wright (Ottawa), and Baby, to assist Mr. Speaker in the direction of the Library of Parliament, so far as the interests of this House are concerned, and to act as Members of a Joint Committee of both Houses on the Library.

Ordered, That the Clerk of The House do carry the said Message to the Senate.
