UNEMPLOYMENT INSURANCE COMMISSION IN QUEBEC

Question No. 2,385—Mr. Fortin:

- 1. Following an inquiry by the Unemployment Insurance Commission in Quebec, which revealed that more than 40 per cent of the claimants did not attend H-PEVAIC interviews when they were summoned in writing as compared to those summoned orally, did the Department of Manpower and Immigration decide to summon candidates in writing despite the study and, if so, for what reason?
- 2. Did the decision of the Department take into account (a) the intelligibility of the UIC forms (b) the fact that, according to the Centrale des enseignants du Québec (Quebec Teachers' Union), 40 per cent of the adults of the Province have only an elementary level education and thus the most deprived are the ones who are victims of exclusions and, if so, has such a procedure been adopted across the country?

Hon. Bud Cullen (Minister of Manpower and Immigration):

- 1. No. The Department is of the opinion that summoning claimants in writing is better business practice than giving them appointments orally. In that way, there can be no misunderstanding as to the time and place of the interview and the name of the counsellor.
- 2. (a) Yes, the Department periodically reviews its forms in order to ensure that they can be understood by all claimants. As for the form used to summon them for interviews we feel that it is perfectly intelligible. (b) No.

CBC ENGLISH LANGUAGE TV AND RADIO STATIONS IN QUEBEC Question No. 2,444—Mr. Cossitt:

Since April 20, 1968, how many CBC English language (a) tv (b) radio stations, have been constructed or planned for the Province of Quebec and, in each case, what are the call letters and the location?

Hon. John Roberts (Secretary of State): I am informed by the Canadian Broadcasting Corporation as follows: (a), (b) In the province of Quebec since April 20, 1968, 11 English-language television stations and 13 English-language radio stations have either been constructed or their planned construction has been announced in connection with a CRTC hearing for a licence application.
