USE OF FACILITIES FOR LIBERAL PARTY CONVENTION—MOTION UNDER S.O. 43

Mr. Tom Cossitt (Leeds): Mr. Speaker, I rise under the provisions of Standing Order 43 concerning the event scheduled to take place in the parliamentary buildings on Friday, February 24, allegedly involving the setting up of 26 bars and the participation of approximately 4,000 people as part of a convention being held by the Liberal Party of Canada. I move, seconded by the hon. member for Winnipeg South Centre (Mr. McKenzie):

That this constitutes abuse and blatant misuse of the privileges afforded to members of parliament, as well as degrading the dignity of the parliamentary buildings, that particularly at this time these buildings should be used for solving the problems of unemployment and inflation, rather than as a gigantic cocktail lounge for members of the Liberal party and, finally, ask that the Speaker review the matter in order that the parliamentary buildings will not be debased by a booze-bash and become known as "Trudeau's tavern".

Some hon. Members: Hear, hear!

Mr. Speaker: Order, please. I have some difficulty about putting the motion. There are notices of questions of privilege to be raised about the same matter, and I am certain it will necessitate a long discussion later. It involves a decision that I made in terms of the initial permission for the use of the parliament buildings. However, the question involves legitimate discussion concerning the extent of the arrangements since the original permission was given; therefore, I will give the benefit of the doubt to the hon. member and ask if there is unanimous consent that the motion be put.

PRIME MINISTER URGED TO CANCEL PLANS TO USE PARLIAMENT HILL FACILITIES—MOTION UNDER S.O. 43

Mr. Edward Broadbent (Oshawa-Whitby): Mr. Speaker, I have a motion on the same subject, which I agree is extremely serious. The Prime Minister (Mr. Trudeau) said recently in British Columbia, "There are no free lunches". Considering

that the Liberal Party of Canada plans to turn Parliament Hill into a colossal free lunch for their convention that is to take place later this month, using parliament's facilities, which are paid for by the taxpayers of Canada, to provide what one Liberal officer has described as "a mammoth bash", and considering that another Liberal planner is quoted as saying, "Who wants to drink and dance in some hotel basement room when you can use parliament?", I move, seconded by the hon. member for Winnipeg North Centre (Mr. Knowles):

That this House urges the Prime Minister to practice what he preaches and take steps to ensure the Liberal party cancels its plans to use parliament's facilities to provide themselves with "a mammoth bash".
