

WANT WHARVES ON RIVER TO BE NAMED

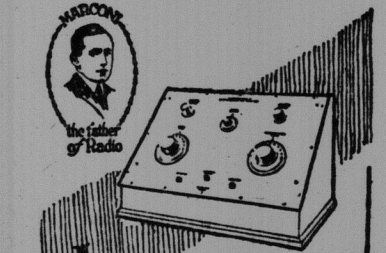
