SHAUGHNESSY HOSPITAL, VANCOUVER-SALARIES OF STAFF

On the orders of the day:

Mr. T. C. Douglas (Burnaby-Coquitlam): I should like to direct a question to the Minister of Veterans Affairs. It has reference to the house. The answer to part 13 of that question indicates that present rates of pay for ward nurses, nursing assistants and orderlies are lower at Shaughnessy hospital than in other hospitals in Vancouver. I should like to check into that and make sure. to ask the minister what steps he has taken to rectify this situation in order to bring the salaries for these groups of persons at Shaughnessy hospital into line with other hospitals in the Vancouver area.

Hon. Roger Teillet (Minister of Veterans Affairs): Mr. Speaker, as the hon. member knows, the difficulty in this situation is that our rates of pay are based on national rather than regional considerations. While these rates of pay in Vancouver are perhaps lower than the rates prevailing in that area, we find we are higher in other areas. It would therefore be a matter of adopting a regional policy rather than a national policy. I think the hon. member would agree it is an extremely difficult problem and one, I can assure him, that we are facing and thinking about continually. What the answer is to the problem at the moment I could not say.

Mr. Douglas: May I ask a supplementary question. I agree with the minister that it is a difficult question, but would he not agree that unless some adjustment can be made to meet competitive rates it is not going to be possible to keep good staff, or it means asking the staff to make sacrifices which we have no right to ask them to make?

Mr. Teillet: Of course that is the essential problem with which we are wrestling in the department. It is a difficult one. I do not want this to be taken as a suggestion of policy, but it is one of the things for which we may have to find some answer because of the difficulties in recruiting which have been mentioned.

Mr. Harold E. Winch (Vancouver East): May I ask a question of the minister. In view of the fact that in a good many departments in Vancouver the prevailing rate system is rate? Other federal employees receive the and 15 had been allowed to stand. [Mr. MacEachen.]

Here you have a differentiation in rates of between \$80 and \$100 per month for orderlies employed in the Shaughnessy hospital and those employed in the Vancouver General, St. Joseph's or St. Paul's hospitals. How can you have one policy while other departments have another?
