Cork, Oct. 30.—The fighting which took place between the McCarthyites and Parnellites Wednesday night in the streets of this city was more serious than it appeared from the first reports. There was a series of scrimmages between the contending parties, the most severe being the one in which Mr. Dillon was disabled. Crowds of McCarthyites, were accompanying Mr. Dillon and Mr. O'Brien, who were on their way to attend a McCarthyite meeting in the market place. The McCarthyite scame into collision with a torchlight procession of Parnellites. The latter was headed by a brass band composed of some of John E. Redmond's most enthusiastic supporters. Neither crowd would give way to the other, and a hot and general melec followed, several thousand persons taking part. Blackthorns were used with effect by both parties, and bricks and stones flying through the air added to the ardor of the rival factions and considerably increased the excitement. Finally the McCarthyites succeeded in wrenching the torches from the hands of the Parnellites, quenched them with yells of delight, and after completing the rout of their enemies the victorious McCarthyites continued their march.

AN ANIMATED SCENE.

Upon arriving at the market place, William O'Brien addressed a meeting composed of 5,000 McCarthyites, who vigorously applauded the telling points made by that orator. The market square was illuminated by scorces of blazing tar barrels and a small forest of torches. To such a degree was the enthusiasm of the multitude aroused by Mr. O'Brien's glowing words that many of the women, who plentifully spinkled the throng, were worked up to such a pitch of excitement that they climbed upon the jaunting car from which O'Brien was delivering his impassioned address and tried to embrace the speaker.

THE TRIGGER.

William Rigden, the rifleman who broke the world's snap-shooting record with a 22-caliber ball, 20 pennies out of a possible 25 thrown in the air, is, says the Chicago Herald, without question the finest shot in his line in the United States. He is little known save to a limited circle of marksnen in Illinois, for the reason that he shoots wholly for his own amusement and has never taken part in tournaments or matches. He taken part in tournaments or matches. He discovered his remarkable talent as a rifletaken part in tournaments or matches. He discovered his rémarkable talent as a rifleman through an accident in killing swallows on the wing, and at once began practicing at snap-shooting. For nearly five years his work was done spasmodically, but about four years ago he began regular practice, shooting not less than 500 shells a day. He has no favorite target, but shoots glass balls, pennies, pebbles, white beans and other small objects. Rigden considers the use of shot cartridges demoralizing and will not use them under any circumstances, prefering the small 22-caliber ball, as it is the most difficult. He exercises great care in selecting his guns, and has several splendid weapons, which he holds priceless. Truly phenomenal was his latest score with glass balls in a 500-ball shoot at the old Lime Kiln shooting grounds, he breaking 490 balls with 22 short ball cartridges out of a possible 500, while over 150 balls were broken before he missed. He has frequently broken 480, 483, 485 glass balls out of a possible 500, and expects in a short time to be able to break 500 without a miss. One of his favorite shots, and one requiring great skill, is the double. He has his time to be able to break 500 without a miss. He has his thrower select a pebble, about the size of a glass ball, and toss it into the air at a regulation height and distance, and will strike the pebble twice before it touches the ground, breaking the pebble before the second shot. This is a wonderful feat, but he seldom falls of performing it at the first trial. Here is another favorite shot: He faces the thower, gives the order to throw, turns completely around and breaks a glass ball before it has fallen half way to the ground.
