 NORTH ALBERTA—Includes all that part of the provisional district of Alberta bounded on the south by the 9th correction line between townships 34 and 35; on the west by the eastern boundary of Brit. Columbia; on the east by the line between ranges 10 and 11 west of the 4th prin. meridian. Registrar—George Roy, Edmonton. A. Prince, Deputy Regr.  
 SOUTH ALBERTA—Includes all that part of the provisional district of Alberta bounded on the south by the International boundary line; on the west by the eastern boundary of British Columbia; on the north by the 9th correction line between townships 34 and 35, and on the east by the line between ranges 10 and 11 west of the 4th prin. meridian. Registrar—W. R. Winter Calgary.  
 EAST SASKATCHEWAN—Includes all that part of the provisional district of Saskatchewan bounded on the east by the western boundary of Manitoba; on the west by the line between ranges 10 and 11 west of the 3rd principal meridian; on the south by the line between townships 34 and 35; on the north by the 18th cor. line, D G. Surveys. Regr.—S. Brewster, Pr. Albert.  
 WEST SASKATCHEWAN—Includes all that part of the provisional district of Saskatchewan bounded on the east by the line between ranges 10 and 11 west of the 3rd prin. meridian; on the west by the line between ranges 10 and 11 west of the 4th princ. meridian; on the south by the line between townships 34 and 35; on the north by townships surveyed.
