This having been said, I have no alternative but to make a ruling in conformity with the British precedents relating to reasoned amendments and to tell the honourable Member that I do not think that the amendment as proposed is acceptable. I do so with regret because I appreciate the importance of the matter and the willingness and anxiety of honourable Members to discuss in relation to the second reading of the bill now before us that aspect of the matter raised by the honourable Member for Brandon-Souris. My conclusion must be that the amendment cannot be put.

Debate was resumed on the motion of Mr. Chrétien, seconded by Mr. Macdonald (Rosedale),—That Bill C-187, An Act respecting minerals in the Yukon Territory be

now read a second time and referred to the Standing Committee on Indian Affairs and Northern Development.

And debate continuing;

Mr. Simpson, seconded by Mr. Ritchie, moved in amendment thereto,—That all the words after "That" be struck out and the following substituted therefor:

"this Bill be not now read a second time but that the subject-matter thereof be referred to the Standing Committee on Indian Affairs and Northern Development."

After debate thereon, the question being put on the said proposed amendment, it was negatived on the following division:
