to confer with my hon, friend and with the representatives of other groups in the House in preparing the report. Speaking for the government, I may say that I have every desire to treat fairly all sections of the House.

Motion agreed to.

### INTERNAL ECONOMY COMMISSION

Right Hon. W. L. MACKENZIE KING (Prime Minister) presented the following message from his Excellency the Governor General:

I also desire to lay on the table, for the information of the House a statement prepared in the Department of Finance showing in months and in the aggregate, the amount of governor general's warrants issued since dissolution for the various departmental services.
