with the innocence of the bill as explained by my friend, the hon. member for Peel (Mr. Graydon). The measure seems to step up the annual valuation from \$30,000 to \$100,000. I am not certain that the bill is in the public welfare of the people of Canada, much less the people of Toronto. Because of that I wish now to make a public protest against its passing. If it is merely the passage of a bill to procure some election funds for the Conservative party, I still protest it. I am not in favour of its being carried. I have not found anything yet to convince me that the bill should be allowed to go through. If the *Globe and Mail* has an annual valuation of \$30,000 to \$100,000 and it is willing to give that up so that the Globe Printing Company can go along with it, then I would be in favour of it, but I cannot find anything in the bill that will show that the *Globe and Mail*, or any other company, is going to give up its rights to an annual valuation of \$100,000. I do not think that my protest will carry the weight that it should, but I wish to go on record as protesting the passage of the bill. I will not call it an iniquitous bill because that expression has been used by others in the house and out of the house, but I will say that I am not in favour of its passage.
