NATO-INQUIRY AS TO REPORTED MEETING OF FOREIGN MINISTERS

In this connection I should like to stress that, as I said on June 22, the Canadian government attaches great importance to the consultations on this question of the Geneva conference which have been taking place in the NATO council and are still continuing. It is in these consultations that Canada is particularly interested.
