MINI-TYPE SUBMARINE—CANCELLATION OF EXPORT PERMIT ISSUED TO INTERNATIONAL HYDRODYNAMICS

Having in mind the statement made in the House yesterday by the Minister of Industry, Trade and Commerce to the effect that Canada's security was the sole reason for our about-face in cancelling the export permit for the baby submarine being made in Vancouver for sale to Russia, despite the fact he indicated that some consultation had taken place between Canada and the United States, does the minister know that American components were used in the construction of this submarine? Second, does he know that, so far as defence elements are concerned, this baby vessel can only be used if connected to a mother ship?

Mr. Speaker: Order, please. The question is hardly in order. The member is asking whether the minister knows certain information. The question in those terms cannot be accepted.

GRANT TO BRING WRITERS FROM EUROPEAN COUNTRIES TO INSTRUCT CANADIANS

Right Hon. J. G. Diefenbaker (Prince Albert): Mr. Speaker, my question is directed to the Secretary of State who I believe reports for the Canada Council. I base my question on information from the Canadian Authors' Associa-

tion having to do with a grant by the Canada Council of \$100,000 to bring in writers and scholars from five European countries at salaries of up to \$1,000 per month to tell Canadians how to write. Of the 39 who have been designated, 34 are from France and the others are from West Germany, Belgium and Italy. None are from the United Kingdom, none from the United States, and none from Canada. Will the minister look into this matter and ascertain the basis on which this huge amount of money has been expended, and whether consideration was given to our authors in Canada, even to the members of the Press Gallery here—

Some hon. Members: Oh, oh!

Mr. Diefenbaker: —who know how to write and do not have to have foreigners come here to tell Canadians how to write?
