#### ADMINISTRATION OF JUSTICE

##### PROPOSED CONFERENCE WITH PROVINCES ON CRIME AND POLICING—GOVERNMENT POSITION

**Mr. Allan Lawrence (Northumberland-Durham):** Mr. Speaker, my question is directed to the Solicitor General. As the Solicitor General indicated more than seven months ago in a committee of this House that the government was considering participating in a federal-provincial conference on crime and policing, can the minister tell the House if a date has been set for the conference?

**Hon. Warren Allmand (Solicitor General):** No, Mr. Speaker. Preliminary discussions have been held with the provinces but, so far, there is no agreement to go ahead with such a conference. On the other hand, at a recent meeting with attorneys general and other provincial ministers we discussed other ways of combating organized crime.

##### RATE OF INTEREST ON LOAN TO LOWER MORTGAGE INTEREST RATE
