### BUSINESS OF THE HOUSE

#### WEEKLY STATEMENT

**Mr. Speaker:** The Hon. House Leader of the Official Opposition has asked the usual business question. The Hon. President of the Privy Council.

**Hon. Ray Hnatyshyn (President of the Privy Council):** Mr. Speaker—

**Mr. Prud'homme:** Give us the menu.

**Mr. Hnatyshyn:** In Saskatchewan we pronounce it "meenu". The discussion to which the Hon. House Leader of the Official Opposition referred has taken place. It is my intention to continue with Bill C-96, the matter we are discussing now on the floor of the House of Commons. Bill C-92 will follow, and the third Bill in the sequence that I have discussed with the House Leaders is the amendment to the Income Tax Act with respect to scientific and research tax legislation.

We are also in the process of discussing other items of legislation and the amount of debate that would be required to deal with those items. As we monitor the progress of the legislation I have mentioned, I will continue to keep in touch with opposition House Leaders so they can advise their Parties and I will also announce to the House any change in the business that may be appropriate.
