Since January 1, 1990, have there been any inquiries made of the government or any of its agencies, boards or Crown corporations regarding a possible sale, lease or other disposal of Royal Roads Military College, its lands or buildings and, if so, who made the inquiries and which departments did they contact?

**Mr. Charles A. Langlois (Parliamentary Secretary to Leader of the Government in the House of Commons and to Minister of National Defence):** Since January 1, 1990 the Department of National Defence has received inquiries regarding a possible sale, lease or other disposal of Royal Roads Military College. However, according to the Privacy Act the names of persons who made these inquiries cannot be divulged to a third party.
