July wheat closed 5c, Sept. 3c and the June delivery 1 1/2c above the previous close. July wheat rose a couple of cents in New York, but the market slumped again in the Northwest.

The Liverpool market was irregular, July wheat closing at an advance of 1 1/2c per cental for the day, and the late options at losses of 1/2c to 3/4c. Paris and Antwerp scored advances of 20 to 25 centimes.

Wheat remains dull at Toronto. Some 100 cars of Ontario red were sold for export at 1 1/2c, twenty thousand bushels of Manitoba hard were disposed of at \$1.18 1/2 at Fort William.

On further reports of damages to corn crop in the West by wet weather that cereal rose 1/2c to 2c on the Chicago board, in Liverpool prices rose 1/4c to 1/2c per cental. Oats are firmer.

The outbreak of yellow fever in the South caused packers to sell provisions at Chicago, where pork declined 3c, lard 1 1/2c and short ribs 1/2c. Lard is 3d lower at Liverpool to-day.

The resolution passed by the Board of Trade council yesterday reads: That, in the opinion of the board, the judgment rendered in White v. Mcintosh is one that would work great injury, if taken as a precedent, in buying and selling commodities, and that owing to the importance of the principle involved, the council hereby endorse the action of the Wharfedale and Milling Section of the board, and pledge themselves to exert all the influence which they may properly exert in support of the remedying of the vicious state of affairs which would obtain if the decision should be regarded as a precedent.

It is understood, by the way, that the farmers of the country also monitor the matter, and that they have called a meeting to be held at the Union Hotel on Saturday, June 18. They will likely suggest the appointment of official inspectors to pass upon the quality of all farmers' wheat coming into the Toronto market.
