

## IMPROVEMENTS AT ROCKWOOD PARK

Reports at Horticultural Society Annual Meeting.

A Deficit of \$1,500—Gift of Rare Animals Acknowledged—Events of the Year—The Financial Statement

Some interesting facts are contained in the reports of the managing committee and the treasurer of the St. John Horticultural Association presented at the annual meeting of the organization held this afternoon.

The report of the managing committee for the year ended January 31 was as follows:—

During the great war a number of young ladies, banded together under the name of the Rockwood Comfort Club, devoted their energies to making and sending useful articles, particularly to their acquaintances at the front. After the signing of the armistice they brought their efforts to a fitting conclusion by erecting in the public gardens a lasting monument of granite to the memory of the seven young men from the immediate vicinity of the gardens "who in the great war gave their lives for the cause of liberty and right." The monument was unveiled in August last with fitting and impressive ceremonies, the president undertaking on behalf of the association that it would be given due care and kept in good preservation.


On January 18 and 19 last the Canadian championship skating races were held at Lily Lake under the management of the Y. M. C. I., which proved a success in every way. Probably more people were at the lake on the second of these days than on any previous day. The attendance was conservatively estimated at 7,000 on the first and 15,000 on the second day, many persons placing the figures much higher.

Two important improvements in the park have been made during the year. The road skirting the southern edge of Lily Lake was widened from the old crooked and narrow drive way to its present straight and broad dimensions. The work proved much more extensive than at first supposed and was well carried out by John Henry, whose intelligent work as head keeper is worthy of praise. In consequence of this work it was not possible to give the same attention to other roads and to the paths as formerly, but these will receive particular attention during the coming year.

The other important improvement was in connection with the water supply to the drinking fountain near what was the deer enclosure and for the use of the animals. This supply had for years run from Crystal Spring through an open trench cut through a bog to the northwest of the pleasant house. To do away with this dangerous condition a trench was dug and in this were laid pipes from Crystal Spring to the drinking fountain, a distance of nearly 800 feet. A portion



OVER THE WIRES

In a letter to the premiers of Saskatchewan, Manitoba and Alberta, Hon. W. L. Mackenzie King outlined a proposal for the return of the natural resources to these three provinces in place of the subsidies they had been receiving.

Hon. Charles Stewart, minister of the interior, was yesterday elected for acclamation for the constituency of Agincourt.

A cablegram was received yesterday by Premier King from Princess Mary thanking him and his colleagues in the Canadian government for the good wishes expressed in a cable sent by him. Yesterday in New York, Charles W. Morse, steamship owner and former banker, his three sons, Ervin, Benjamin and Harry, and eight others, Colin H. Livingstone, George M. Burditt, Nehemiah H. Campbell, Rupert M. Much, W. W. Scott, Philip Reinhardt, Leonard B. Christie and Robert O. White, were indicted in a grand jury on charges of defrauding the United States government of millions of dollars.

Alfred E. Lindsay, alleged swindler of society women, now in the Tombs prison, New York, yesterday denied the accusations against him. This statement is in direct contradiction to a statement of the assistant district attorney that Lindsay had broken down and confessed to many of the charges.

**PARIS, MARCH 1.**—The allied powers are expected to refer the whole question of German reparations back to the reparations commission for decision after a meeting of the finance ministers of their governments here on March 9.

In the month that has passed since the reparations commission referred the last German proposal to the Allies, it has been conducting an intensive investigation of Germany's finances and ability to pay, so that when the question is again put up to it the commission will be in a position to reach a decision quickly.

The reparations officials said the negotiations had not reached a definite point and the agreement would be subject to the approval of the commission and the allied powers.

An Associated Press message from Berlin yesterday stated that a provisional agreement had been reached between the reparations commission and the German government providing for the annual payment by Germany, of 200,000,000 gold marks in cash and payments in kind to the value of 1,450,000,000 gold marks.

**TO BUILD \$800,000 RINK IN BROADWAY**

Iceland Management Will Erect Big Skating Structure at Fifty-third Street.

New York City will have one of the most modern and elaborate ice skating palaces in the U. S. by next autumn, according to an announcement made by the management of the present Iceland rink, under whose auspices the new rink, which will take up the greater part of the block bounded by Fifty-third street, Broadway and Eighth avenue, is scheduled to start the first of next month and is expected to be finished about the first of October.

The cost of this winter sport plant will be about \$800,000. More than half of this sum represents the purchase price of the building site, which is now occupied by the negro Y. M. C. A. and several tenement buildings. The land and buildings were bought a year ago.

When completed, the rink will include many novel features and all the latest improvements that have been developed within the last few years. Not only will it take care of the present demands of skating enthusiasts, but will be suitable for the future.

There will be a skating area of 200 by 80 feet and in addition to the ordinary facilities there will be club rooms, separate lockers and many other features. The new ice palace will be under the management of Daniel C. Webb.

**SERIOUS FOR SHIP OWNERS OF BRITAIN**

London Chronicle Comments on Proposal for U. S. Merchant Marine Subsidy.

London, March 1.—President Harding's proposal for a United States merchant marine ship subsidy was crowded out of several of the London newspapers by the accounts of Princess Mary's wedding, to which every journal devotes many pages.

Only the biggest newspapers print more than a brief summary of the president's statement to congress, and the Daily Chronicle, the only one to comment, says that America's position of a huge fleet of merchant shipping was bound to evoke some such proposals and that nobody need be surprised.

Nevertheless, it adds, the position created for British ship owners—themselves very hard hit by the collapse of the world's trade—is a serious one. For the moment "we can only take note of these proposals, but not without expressing profound regret that so strong a lead should be given in such quarters to what is from a world standpoint a most reactionary trade policy."
