The Committee carefully examined the following documents, and recommend that they be printed, viz :—

Statement of payments charged to Unforeseen Expenses by Orders in Council from 1st July, 1881 to date, in accordance with the Act 44 *Victoria*, Chapter 2. Schedule B. (No. 15.)

Report of the Librarian of Parliament. (*Sessional Papers only*.) (No. 13.)

Second Report of the Civil Service Commission dated *Ottawa*, the 28th July, 1881. (No. 32.)

Minority Memorandum of Messrs *Taché* and *Tilton*, Members of the Civil Service Commission. (No. 32a.) (*An edition of these two documents to be printed sufficient to give the Members two extra copies.*)

Statement of all allowances and gratuities granted since last Return under the Act 33 *Victoria*, Chapter 4, relating to Superannuation. (No. 33.)
