in that he

at Valcartier, Quebec, at 0800 hours on the 27th December 1944, absented himself from A-13 C.I.T.C., C.A., until surrendering himself to Military Authorities at Ottawa, Ontario, at 1420 hours on the 1st October 1945, dressed in civilian clothes.
