THE MARTYRED MISSIONARIES
VICTIMS OF FRENZIED MOBHospital, Residences and Schools Were Burned and
Americans Driven to Cave for Refuge.

Hong Kong, Nov. 3. — Bishop Merle, of the Catholic Church has received a letter confirming the news of the massacre of American missionaries at Lien Chow, and giving the following particulars:

Dr. Machie requested the removal of a street theater near the hospital on account of the noise. This request incensed the Chinese, who, in becoming violent, attacked the hospital. The mob then paraded the street, exhibiting the skeleton used in the instruction of the medical class, and alleging that it was an example of the foreigners' inhumanity to the Chinese people.

Becoming frenzied, the crowd burned the hospital, the girls' school and residences of the missionaries.

Take Refuge in a Cave.
Dr. Machie, Mrs. Machie, their 10-year-old daughter, Mr. and Mrs. Pearle, Dr. Chestnut and Miss Patterson took refuge in a cave. The mob pursued them and killed all except Dr. Machie.

and Miss Patterson, who escaped to the Yamen. Dr. Machie was badly wounded.

The American gunboat Callao and two Chinese gunboats, with members of the American board of missions, are proceeding to the scene of the massacre.

Advices from Canton declare that the measures taken to suppress disturbances in the provinces are inadequate, and that the native officials will not give out any information on the subject. The Catholic converts have written to Bishop Merle to petition the viceroy of the province for the protection of the French mission at Lien Chow.

It is declared that the boycott headquarters at Canton received the first news of the massacre of the American missionaries at Lien Chow, but the native gentry assert that the boycotters are not connected with the slaughter.

MONSTER WHALES
IN FIERCE BATTLEOver Twenty Dead Leviathans
Washed Up on Pacific Coast
After Swordfish Fight.

Santa Barbara, Cal., Nov. 3. — The bodies of over 20 dead whales, known as "killers," are floating in the channel off Santa Cruz Island, 30 miles from this city. They measure from 20 to 40 feet in length, and bear evidence of a fierce battle between the monsters. This warfare has been going on between two varieties of whales and swordfish for several weeks in the ocean near the Channel Islands, and it is probable that in the extermination of so many of these varieties of whales a signal victory has been won by some of the leviathans.

WAS ON THE KALIYUGA
Body of Man With Lost Life
Preserver Comes Ashore.

Port Elgin, Nov. 2. — The body of a man from the wrecked steamer Kaliyuga was found on the breakerwater here today. The body was washed up by the recent storm, and had on a life-preserver with the name of the ill-fated vessel.

The man would be about 45 years of age, 5 feet 7 inches tall, dark mustache, and had in his pocket a five-dollar bill and silver dollar, both American money. It was evident death was caused by exposure and not drowning. The marine authorities at Port Huron have been communicated with and the body held for information.

CROWE WAS COMING TO LONDON
WITH THE ROCKEFELLER RANSOMIntended to Secrete \$2,000,000
Here Had the Scheme
Gone Through.

Detroit, Nov. 3. — "Of course I was going to kidnap Rockefeller. Why should not I? It would be far easier to run away with him than it was to carry off a child like Edward G. Cudahy, Jr. In March of this year it was my intention to go to Cleveland, kidnap Rockefeller, the oil king, and demand a ransom of \$2,000,000 from his son under penalty that if the ransom were not paid immediately I would 'put the old man off watch.'"

"If my pal, whose name I will not divulge, had not thrown me overboard I would not today be a prisoner in the hands of Omaha detectives. "Only about \$3,000 in cash was necessary to carry out the plot to kidnap Rockefeller. I visited Forest Hill, near Cleveland, viewed the surroundings and considered it would be easy work to make the multi-millionaire a prisoner. I had planned to hire a hand-somely-equipped residence in the suburbs of Cleveland, and this residence would have held Rockefeller a prisoner until the ransom was delivered to me. I should have commanded Rockefeller's son to cross Lake Erie in a small tug, manned by not more than a dozen men, and take with him \$2,000,000 in gold.

"As the tug neared the Canadian shore a red light flashed upon a pole would be seen. Tethered to this pole would be a scow. In this scow the bags of gold were to be deposited. "As the tug pulled up to the red light the instructions were that a rocket should be fired from the vessel. "This was to be the signal by which I should know that the money was on hand."

ROBBERY CHARGE
AGAINST SMARTHotelkeeper and His Bartender
Said to Have Taken Farmer's
Money and Watch.

John Smart, a hotelkeeper at Odell's, Westminster Township, and William Cotton, his bartender, were arrested yesterday afternoon by Detective Northrup for a charge of robbing W. H. Martyn, of Westminster. Martyn complained some time ago that when he was in Smart's hotel on Oct. 11 last he was relieved of \$122 and a watch. He accused Smart and Cotton of the crime, but nothing was done for some time.

TOOK PARIS GREEN.
East Zorra Girl Takes Fatal Dose
No Cause Assigned.

Woodstock, Ont., Nov. 2. — With a large tablespoonful of Paris Green, Miss Martha Collins committed suicide at her home on the twelfth line of East Zorra today.

She took the fatal dose late last night, unknown to her friends in the home. About midnight the other members of the household were aroused by her moans. Later she vomited.

RUSS PRESS NOW FREE
All Government Regulations With-
drawn by the Imperial Order.

St. Petersburg, Nov. 3. — All the regulations issued by the government by circular for their enforcement have been withdrawn, and the chief of the press administration has been prohibited from further issuing such regulations.

Another appeal to the people in the shape of an official note was published this morning. It says: "After the manifesto of Oct. 30 had laid an unshakable foundation for the development of Russian life on the basis of legality and justice, participation in street demonstrations has a significance altogether different from that attaching thereto previously. It can only encourage disorder, and the presence of pupils of the middle and lower educational establishments among the demonstrators is much to be condemned if only on moral grounds. Unless the attention of society be now directed to the fact that society is threatened with dangerous increase in the number of people whose respect for authority and order is being radically shaken, while they are still in the schoolroom. The government therefore call on all citizens to encourage quietly their own avocations."

Big Fire at Easton.
Easton, Pa., Nov. 3. — A fire which broke out in Mauch Chunk early today is beyond control. The Amoyan House, the leading hotel in Mauch Chunk, is in flames and the court house is in flames and will be a total loss, while surrounding property cannot be saved.

BETWEEN DEVIL
AND DEEP SEAWhere Temperance People
Placed Some Aldermen.

MOVE REGARDED VERY SMOOTH

Validity of Council Taking Desired
Action Is Questioned—Some
Points Raised.

In civic circles the manner in which the temperance people have gone about their move for the reduction of the number of liquor licenses in London is regarded as exceedingly smooth and clever. To make their meaning clear on the subject, the Temperance League asked the council to allow a delegation to address the mayor and aldermen on Monday night, when it is probable the whole matter will be threshed out.

To put it in the words of one alderman, the temperance people have now placed the vacillating city fathers—that is, those of them who are vacillating—between "the devil and the deep sea." It is now a case of either vote to give the people a chance to say whether they want the number of licenses reduced, or else say that the people have no right to an opinion on the subject.

One Question Ruled.
Some question has been raised as to the validity of the council passing a bylaw for two readings, to reduce the licenses, and then leaving the third reading over for the result of the appeal to the people, as this means that the council of this year is in a way passing laws for the council of next year. But if this point is persisted in, it is likely that the temperance people will request the council to submit the bylaw to the people anyway, no matter whether or not a bylaw to reduce the licenses is read at all this year.

Another interesting point is being raised this year, and it is whether the commissioners must act on the reduction if the people decide in favor of it. Of course, it is hardly likely that the commissioners would fly in the face of public opinion, but it is said that it is optional with them whether they reduce the licenses, even after the people have sanctioned the proposed reduction.

Council Will Favor Proposal.
It is understood that the proposal to submit the question to the people will have a majority, one of the aldermen figuring that if the council will support the proposal, and the mayor has also signified his intention of voting for it.

The question then arises as to whether the matter is not identifying himself with the temperance movement.

"For my part, I am ready to let the people have a say on any matter which arises."

It is understood, adverse to the proposal to allow the matter of license reduction to go before the people at the same time as men to manage the city's affairs are being chosen as the temperance question introduced at that time is liable to result in the city's affairs being managed by the people may become more interested in the temperance matter than in the other matters of the general welfare of the city.

RUSSIANS AFTER PERKINS
Morgan's Lieutenant Runs Blockade
of Finn Revolutionists.

Stockholm, Nov. 3. — George W. Perkins, J. Pierpont Morgan, Jun., Mr. Baring, and other financiers, arrived here today from St. Petersburg on board the Russian steamer Olhonna. Mr. Morgan proceeded immediately to London, Mr. Perkins remains here until Saturday. Mr. Perkins said that when they succeeded in chartering the Olhonna at Helsingfors, the strikers tried to prevent the steamer from sailing for St. Petersburg. Her captain, however, succeeded in eluding them.

BIG YIELD OF GOLD.
Royalty on \$7,000,000 Already Paid
Into the Dominion Treasury.

Ottawa, Ont., Nov. 3. — The Government has received royalty on over seven million dollars' worth of gold produced in the Yukon this year. The Klondike's gold production to Oct. 19 was \$7,085,000. The per capita output of gold for the first ten months of 1905 is about \$1,500. No other camp in the world produces such a per capita.

The gold output here is figured at \$15 per ounce, while the American side is \$16 per ounce.

The royalty is 24 per cent. There may have been several more millions recovered from the mines which was used in the ordinary business of the country.

No export tax will be paid till the gold leaves the country, so that the additional output has not yet figured in the schedule.

TO HELP SEAMEN.
After Widow's Death Inverclyde's
Estate Will Go for Charity.

Edinburgh, Nov. 3. — The Scotsman says that Lady Inverclyde, widow of Lord Inverclyde, late chairman of the Cunard Steamship Company, accidentally found a will of later date than the one in which Lord Inverclyde bequeathed all of the Inverclyde House, of Glasgow, to form a fund, to be called the Inverclyde bequest, the annual income of which is to be devoted to charities for the benefit of merchant seamen. One-fifth of the fund is to be divided between similar charities in New York and Boston.

EASTERN LEAGUE RUMOR
President Says Not After American
Association Clubs.

Buffalo, Nov. 3. — President Harry L. Taylor, of the Eastern League, said today relative to published statements intimating that he might lead a movement looking to the combining of the Eastern League and American Association by taking four of the strongest clubs of each association and forming a new league, that there was nothing in the story. His object, he said, would be to keep the Eastern League intact. Several of the clubs needed strengthening, and it would be his earnest endeavor to help them along, so that the next year would be a more equal one.

MIKADO HAS BIRTHDAY
And Expresses His Satisfaction at
Restoration of Peace.

Tokyo, Nov. 3. — At a banquet given in honor of the birthday today, the Emperor expressed his satisfaction at the restoration of peace, and toasted the governors and rulers of the countries represented at his court. Baron D'Aene, the Belgian minister, and dean of the diplomatic corps, replied to the toast. In the course of his remarks, which were inspired by lofty sentiments of humanity, and added such a beautiful page to the glorious history of his majesty's reign.

He concluded by expressing a wish for the continuance of the growing development of Japan.

Colonel Was Angry.
Winnipeg, Nov. 3. — Capt. Lawlor, governor of the provincial jail, was buried yesterday by the garrison. The only regiment that didn't turn out in force was the Nineteenth Regiment, which only had six men on parade. Col. Chamber, commanding, got mighty wrath after parade, and immediately issued orders dismissing the regimental band.North Pole Expedition.
Brussels, Nov. 2. — An expedition to the North Pole, under the patronage of the Belgian Government, is about to be organized. The expedition will consist of two million dollars, will be defrayed by a national lottery on an extensive scale. The expedition will require three years' preparation.Just Walked Out.
Portage la Prairie, Man., Nov. 3. — Two prisoners at the local reformatory, Frank Glover, aged 16, and Christian Peterson, aged 18, succeeded in making their escape from here, and have not been heard of since. Owing to the overcrowded condition of the jail some of the prisoners have been installed beneath the court house, and when the wardens were in another part of the building the two men walked out and made a bolt for liberty.FRESH RIOTS BEGIN IN ODESSA;
JEWISH QUARTERS PLUNDERED

Odessa, Nov. 3, 2:14 p.m. — After a fairly quiet night shooting began again today. The red cross is busy attending the wounded. Up to the present no Christian shops or residences have been touched. The principal hotels are full of the better class of Jews seeking refuge.

On Oct. 31, after the Emperor's manifesto granting a constitution to Russia had been published, the Jews made the Russians furious with rage by making a prominent display of red flags, trampling on a portrait of the Emperor, and tearing down the emblem of the crown.

Late in the afternoon there was firing in the outskirts of the town, and the massacre of Jews commenced and lasted during the night of Nov. 1. All Jews found in the streets were killed and many were killed in their shops, which were ruthlessly pillaged. Crowds of workmen, rowdies, women and children laden with all kinds of loot, walked openly through the streets, quarreling over the spoils.

Bombs were thrown in various parts of the town. Late last night patrols of soldiers and Cossacks restored some semblance of order. The pillaging was continued, and there was firing all over the town. Nobody was safe in the streets. People carrying arms who were caught by the troops were shot at sight. The shutters of all houses were ordered to be closed, and people detected shooting from windows were promptly shot.

St. Petersburg, Nov. 3. — The decision of the strike committee to order the strike today was received with joy by all classes of the population, as the sense of newspapers, electric light and other conveniences is severely felt. The railroad men, however, have resolved to keep up the strike, which entails a continuation of the high prices of provisions.

SAYS HIGH-LIVING
WAS THE CAUSE
Hamilton Embezzler Lived in
Luxurious Style on a
Small Salary.

Hamilton, Nov. 3. — Manager Turnbull states that nothing official can yet be said as to the amount of Brown's shortage. Street rumor places it all the way from \$50,000 to \$70,000. The bank is taking the most vigorous steps toward tracing up securities and other property that has been bought with the stolen moneys, and the present shortage may be materially reduced. In this action it is understood no assistance has been given by Mr. Brown, who apparently has some object in silence. What that object can be is not evident, unless he had an accomplice in his stealing, who may be saved by silence. No person connected with the bank is at all under suspicion.

The question that everyone is asking is, "What did Mr. Brown do with the stolen funds?" He is the son of Adam Brown, ex-M.P. and postmaster of Hamilton, and there was nothing in his family history calling for the expenditure of large sums. He is a bachelor and lived quietly with his father in the winter in the winter quarters at Burlington in summer with a couple of reputable young Hamilton men. Those who know him best say he is temperate in the extreme, and free from any entanglements with the sort of women who might cause his downfall. It is not believed that he speculated in stocks and securities, as would account for his shortage. If he bought on margin at all it was rarely.

High Living the Cause.
"What did he do with the money?" He had a sort of mania for costly things. It is said the piano and pianola in his possession were of a class far beyond the reach of a man of his means. He carried insurance on an extraordinary scale for a young banker, apparently without any ulterior motive. The premiums on this must have constituted a heavy drain on his resources. Perhaps "high living," as distinguished from "loose living," affords the key to the defalcations.

Outside of his "set" it was not generally known that he was living beyond his means, but it has transpired that he lived at the rate of one thousand dollars yearly, while receiving something like \$2,500 a year salary. At Burlington he entertained lavishly in the summer. He had handsome yachts, luxuriously furnished. He kept nice horses and vehicles, and he occasionally took expensive trips to New York and other cities. It is said that he had 35 suits of clothes, but this is probably an exaggeration. He is a handsome-looking man, over six feet in height, and of a somewhat ruddy complexion, with light-colored hair.

Statement by Bank.
The directors of the bank have made the following official announcement: "The bank of Hamilton is sorry to say that systematic defalcations have been made at its east end branch by Mr. T. Hillhouse Brown, who has been agent since its opening. The embezzlement was going on for several years, and had been cleverly concealed. The loss to the bank, which will be readily provided for out of surplus current profits, is a small matter, in comparison with the regret which is felt over the loss because of trust by any officer so well and favorably known and hitherto so highly respected."

Following the discovery of the defalcation a warrant was issued for the arrest of Mr. Brown, who was subsequently taken into custody by Detective Inspector McMahon this afternoon. There is no more popular man in Hamilton than Mr. T. Hillhouse Brown, and the downfall will be an awful shock to his host of friends. It is said that speculations that did not go right, the over-free spending of money and the cost of a great deal more life insurance than he could carry have been the causes that led to the trouble.

PRINCE LOUIS AT
THE WHITE HOUSEBattenburg Will Meet Roosevelt
and Later Lead Big Ball
at the Embassy.

Annapolis, Md., Nov. 3. — Admiral Prince Louis of Battenburg, Almirante Evans, the officers of their personal staffs, the commanders of the six British armored cruisers, Rear Admirals Davis and Brownson, with their flag lieutenants, and Captain W. St. Coles, commanding the Missouri, came up Annapolis harbor today on board the Yankton, and were met at the boat landing by Admiral Sands. They drove to the Baltimore and Ohio station, leaving about 10 o'clock on a special train for Washington.

Washington, Nov. 3. — A reception by President Roosevelt at the White House, a dinner at the British embassy, and a reception at a dance at the British embassy are the features of today's programme for Prince Louis of Battenburg. The prince will arrive here in a special train over the Baltimore and Ohio shortly before noon. He will be driven to the British embassy for luncheon, and in the afternoon will be introduced to President Roosevelt. Officials of the United States Government and Ambassadors abroad are planning to do the prince great honor on his visit. He will be here for three days' visit here. While plans have been taken to give no official color to Prince Louis' visit to Washington, an impressive feature will be the presenting by the prince of a friendly letter of greeting from King Edward to President Roosevelt. While the prince is being entertained at the luncheon by Sir Mortimer, the captains of his ships will be entertained at luncheon by the captains of the American squadron. The prince's visit will be included in the reception at the White House at 4 o'clock this afternoon. It is probable that a drive to some point of interest in the city will be made. The dinner at the embassy will be a brilliant affair, and at the reception and dance which will follow the introductions have been issued. On Monday morning, Admiral Evans will escort the prince back to Annapolis.

Mount Vernon, O., Nov. 2. — Buried beneath a culvert, 200 feet from the spot where Stuart Pierson, the Kenyon College student, was found to death by a train, the authorities have found three pieces of blood-stained rope and a wad of absorbent cotton, also saturated with blood.

County Prosecutor Stillwell believed the boy was chloroformed, the cotton saturated, bound across his face, and that then he was tied across the tracks as a part of his initiation into a college fraternity. The authorities believe that the cotton was removed later and the boy left stupefied.

On these grounds the prosecutor will carry the case to the grand jury on Nov. 13.

WILL SETTLE IN WEST
Many Imperial Army Officers to
Remain in Canada.

Halifax, N. S., Nov. 2. — Orders were received from the war office today to the effect that the officers of the Fifth Battalion Royal Garrison Regiment remaining in the Imperial service are to proceed by the steamers Kensington and Canada, sailing on Nov. 13 and 21, respectively, for England. Most of the officers have already left, having been transferred to other regiments.

A number of the men are joining the Canadian service and quite a party will settle in the west.

The Royal Canadian Regiment will replace the garrison regiment.
