Toronto, Nov. 15.—In consequence of the present situation of the Central Bank, it has not been able to realize on its assets promptly enough to meet immediate demands upon it.

The resolution adopted by the bankers "Owing to there not being time to acquire information sufficient to estimate the amount of assets available to the Central Bank."
