His discourse was largely an account of the needs of that country and the efforts put forth by the institute to moet these needs. From what Dr. Christie said it appears that the population of Tarsus is a very mixed population. He stated that at his closing exercises last spring recitations were heard in no less than six languages: Arabic, Tarkish, Armonian, Modern Greek, English and French. These different nationalities it seems are year. These different nationalities it seems are very exclusive and suspecious of one another, making mission work among them much more difficult than it otherwise would be. Dr. Christie and his associates direct their energies repecially towards the work of erangelizing the Armeniaus, and great as the difficulties encountered are, he looks to the future in a hopeful spirit. In the course of his remarks Dr. Christie referred to the late Rev. H. S. McKitrick, who was associated with him for some time in the work at Tarans. The speaker some time in the work at Taisas. The speaker in effect said that his late colleague was a young man of great promise, theroughly connecrated to the work to which he had devoted his life, diligent in his studies and emergetic in his evangelistic work, beautifully modest, but of insuly courage. Dr. Christic carries with him the sympathy of the congregation in his return to his difficult and important field of labour.

## Knox College Semi-Centenary.

KNOX COLLECK now enters on the fiftieth year of its existence. The beginnings of the institution were small, and possibly those early friends of the Church who founded the theological school, from which the col-lege has gradually developed into its present importance, formed but little idea of the results which would crown their efforts. results which would crown their enorms. The rise, continuous progress and success of Knox College as a school of evangelical theology, must form a matter of profound thankfulness and gratitude to Almighty God from the whole Presbyterian Church. Through the large number of ministers and ministers who have issued from its halls, and new occupy positions of importance at home and abroad, it has been largely inand new occupy positions of importance at home and abroad, it has been largely infinential in moulding the character and habits of thought of our people, and its teachings have ever been powerfully directed in favour of sound dootrine and vital religion. A brief review of its history may awaken fresh interest in its week and gratify the friends of the institution when they see that their efforts on its behalf have been fruitful in good results. It seems opportune that some steps should be taken at this time, specially and appropriately to acknowledge the Divine goodness towards the college during so many years. The college was instituted to previde for the observation of ministers for the Prosbytorian Church in Canada, which was organized on the disruption of the Church of Scotland. In November, 1814, it was opened in a room on James street, Torosto, with an attendance of fourteen students. The room contained a long deal table, two wooden benches, a few chairs and a range of book shelves. The institution was originally known as "Knex's College," and this name it retained until its
