The Treaty of Amsterdam also makes provisions for unanimity in the Council for the decision-making in new title on "Visas, Asylum, Immigration and other policies related to the Free Movement of Persons".

The new Article 73i, j(2), (3) ,k(1)(a), (2)(a) of the Treaty of Amsterdam has two stages:

a) 5 years period during which the Council acts unanimously, consulting EP, on a Commission's proposal or Member State's initiative

b) after 5 years:

- The Commission has the monopoly of initiative, but with obligation of examining any request made by a MS;

- The Council's unanimity is the general rule; the possible use of QMV is automatic after 5 years in specific areas (procedures and conditions for issuing visas and rules on uniform visa).

The Treaty of Amsterdam extends the unanimity in the Council to the following new responsibilities:

- The implementation of the Schengen acquis;
- The determination of a breach of the Union's principles;
- Measures against racial discrimination;
- The extension of the competence in the common commercial policy (CCP) to services and intellectual property;
- The regulation of the conditions governing the performance of duties of the MEPs;
- The suspension of international agreements and the establishment of a Union's international position.
