Inquiries of the Ministry

A few days ago I asked him if it was true that the centennial commission was going through a crisis. Since then the minister made a statement in Regina which, Mr. Fisher, through some references to the chief commissioner, indicated that this was so. Can the minister tell us if at a recent meeting with him Mr. Fisher tendered his resignation?

Hon. Maurice Lamontagne (Secretary of State): Mr. Speaker, I met Mr. Fisher at a meeting of the national conference on the centennial in Regina and nothing was said in any of our conversations about a particular difficulty that might exist within the centennial commission.

However, a newspaperman told me, yesterday afternoon, that certain problems might exist there, and when Mr. Fisher comes back to Ottawa I intend to see him to find out if such is the case.

Mr. Martineau: Mr. Speaker, I have a supplementary question.

Is it true the Secretary of State said in Regina that Mr. Fisher was not a very good administrator?

Mr. Lamontagne: No, Mr. Speaker.

Mr. Martineau: Mr. Speaker, I should like to put a question to the Secretary of State in order to clear up the answer he gave a few moments ago.

Could he tell the house whether it is true that Mr. John Fisher dissociated himself from the administration of the centennial commission? Could he also tell the house which journalist called his attention to the crisis the commission is or was going through?

In addition, could he tell us whether it is true he informed Mr. Greg Connolly, of the Ottawa Citizen, of the reasons which prompted him to change his mind about the existence of such a crisis?

Mr. Lamontagne: Mr. Speaker, I am of the opinion that the hon, member knows the name of the reporter concerned, since he has just mentioned the name of Mr. Greg Connolly.

As to the new distribution of responsibilities within the centennial commission, that was done following the appointment of Mr. Georges Gauthier as associate commissioner by Mr. Fisher himself and Mr. Gauthier.
