and the issue of a white paper recently tabled by the Secretary of State (Miss LaMarsh) are evidence, in my view, of the intention of the Secretary of State and of the government, to go ahead always in the field of broadcasting, in order to achieve, to the greatest possible extent, the objectives set out by the present act on the Canadian Broadcasting Corporation and confirmed by the white paper, including, among others provision of complete and balanced information and entertaining and service to both official linguistic groups.

In closing, Mr. Speaker, I can tell the hon. member for Sherbrooke that it is the most eager desire of the government, of the Department of the Secretary of State and of the Canadian Broadcasting Corporation to see to the establishment throughout Canada, of French language radio and television stations in order to serve and do justice to the French population across the land.

STATEMENT RESPECTING THREATENED STRIKE

Hon. E. J. Benson (Minister of National Revenue and President of the Treasury Board): Mr. Speaker, with the unanimous consent of the house I would like to say just a few words with respect to something that is very worrisome to everyone in Canada today, namely, the threat of a postal strike.

Mr. Benson: Mr. Speaker, I realize it is very unusual that I should rise at this time to say something, but I think the matter is of great interest to all members of the house and to all the people of Canada. Negotiations are going on from moment to moment, and I think members of the house should be the first people to know that the government is very optimistic that within a very short period of time this whole matter will be resolved and we will be making a settlement with the people involved. For this I would like to express the government of Canada's great appreciation to Mr. Justice Montpetit.
