Mr. Alexander: I wish to rise on a point of order, Mr. Speaker. I am sorry if I misled the minister but according to *Hansard* of March 25, in answer to the question of the hon. member—if Your Honour will allow me—

Mr. Speaker: Order, please. It is my hope that we will not go into this. It is rather bad practice to read from *Hansard* a question that has been asked. Perhaps the minister might be given an opportunity to give a supplementary answer.

Mr. Alexander: May I ask a supplementary question? Will the minister inform us whether it is his intention now to visit all the urban renewal areas in Canada before he comes to a decision on the plans of the government for urban renewal schemes.

Mr. Hellyer: Regrettably I will not be able to visit them all, but I do hope to visit the eight or ten most urgent projects, to see exactly what is involved, in order to reach some judgment in respect of the total program so that, having taken a decision in respect of one or two, the precedent will hold in respect of the others that are outstanding.

Mr. Speaker: Order, please. I should like to bring to the attention of hon. members the fact that we have reached the period which is normally assigned to private members business. I wonder what the desire of the house is in this regard.

Hon. Donald S. Macdonald (President of the Privy Council): I wonder if there would be a disposition on the part of hon. members generally, and particularly the hon. member for Vancouver East (Mr. Winch) who would have had an opportunity today to speak in the private member's hour, to suspend the private members business and to continue with routine proceedings.

Mr. Harold E. Winch (Vancouver East): Mr. Speaker, I should like to ask that we do not waive private members hour, because under private members business for today is notices of motions, and today is the fortieth and last day for most of them to be discussed.
