**HARBOURS****VANCOUVER, B.C.—THIRD CROSSING OVER INNER HARBOUR**

**Mr. Harold E. Winch (Vancouver East):** Mr. Speaker, anticipating your usual understanding and benevolence, I should like to direct my question to the Minister of Public Works. In view of the fact the government is committed to constructing a third crossing over the inner harbour at Vancouver, and of the special engineering report, which is now several weeks overdue, according to the contract let with this company last August, can the minister now state when the report is now expected, so that local planning can take place and the calling for tenders can proceed without further undue delay?

**Hon. Arthur Laing (Minister of Public Works):** Mr. Speaker, I should like to draw to the attention of the hon. member the fact that this work is being undertaken by the National Harbours Board. The minister who answers for that board is the Minister of Transport.

**Mr. Winch:** In view of that answer, and I understood this was within the responsibility of the Department of Public Works, may I direct this question to the Minister of Trans-

port, anticipating the same confusion created in the past in respect of other matters?

**Hon. Donald C. Jamieson (Minister of Transport):** Mr. Speaker, I regret that I cannot answer with that degree of co-operation indicated by the hon. member. I can only say that I intend to go personally to Vancouver to get a firsthand view and a clear picture of the situation, in order that matters may proceed without undue delay.

**CONSUMER AFFAIRS****COMMITTEE STUDY FOLLOWING APPOINTMENT OF PRICES AND INCOMES COMMISSION**

**Mr. James A. McGrath (St. John's East):** Mr. Speaker, I should like to ask the Minister of Consumer and Corporate Affairs whether, in view of the pending appointment of a prices and incomes commission and amendments to the Combines Investigation Act, it is his intention to recommend the setting up of a special parliamentary committee?

**Hon. Ron Basford (Minister of Consumer and Corporate Affairs):** Mr. Speaker, I want first of all to clear up the implication in the question that both these are pending at the same rate. I hope to announce very shortly the appointment of the prices and incomes
