Hon. J. J. Greene (Minister of Energy, Mines and Resources): The general managers of the Nova Scotia and New Brunswick Power Commissions, accompanied by senior staff, met yesterday with power development and marine construction specialists of the federal government. The meeting discussed in considerable detail the basic assumptions underlying the 1969 report of the Atlantic Tidal Power Programming Board and agreed on a program of review of areas where changed conditions since 1969 may have altered the competitive position of tidal power.

The review committee will report to the general managers of the two provincial power commissions and to the assistant deputy minister for energy of my department. Their work will touch on such matters as interest rates, escalation of costs of tidal and conventional power generation, and new developments in generation and construction techniques.

PROPOSED FARM ADJUSTMENT PROGRAM—REPRESENTA-TION FOR ORGANIZATIONS ON COMMITTEE
