tive economic conditions. In a recent speech, the Governor of the Bank of Canada, while stressing that "the banking system would continue to be in a position to accommodate reasonable growth in bank lending", expressed the view that "the recent pace of bank credit expansion had clearly been too rapid".

3. The extent to which prices in Canada will rise in 1973 is dependent upon a great many factors other than the increase in money supply in 1973.

# APPEALS UNDER SECTION 20 OF THE PUBLIC SERVICE EMPLOYMENT ACT

# Question No. 2,046-Mr. Yewchuk:

Since March 1967, how many candidates have appealed against the decision of the Public Service Commission, because of the provisions in Section 20 of the Public Service Employment Act and Regulations?

Hon. James Hugh Faulkner (Secretary of State): I am informed by the Public Service Commission as follows: The statistics kept by the Appeals Branch do not permit a direct reply to the question as posed. However, the Appeals Branch is able to provide some information relating to the topic covered in the question.

Statistics indicating the key issues raised at appeal hearings have been kept since January 1, 1972. During the 16-month period from January 1, 1972, until April 30, 1973, issues relating to language requirements were raised in

110 appeals out of a total of 3,530 appeals heard. Of these, 44 were allowed and 66 dismissed. This category of the Appeals Branch statistics includes allegations of irregularities and/or unfairness with regard to three Sections of the Public Service Employment Act: Section 14(2) which deals with the language of notice of a proposed competition, Section 16(2) which deals with the language in which an examination, test, or interview is to be conducted, and Section 20 which deals with the language qualifications necessary of employees in order that the functions of the department, portion or part can be performed adequately and effective service provided to the public. Section 20 of the Public Service Employment Regulations deals with the establishment, period of validity, and extension of eligible lists. The Appeals Branch statistics do not indicate appeals against this section of the regulations as a key issue in appeals hearings.
