upon entering the Park will receive the brochure along with other material about the Park. (b) a new exhibit for the Lobster Cove Lighthouse is in the design stage. (c) a new interpretive trail has been established at Lobster Cove. (d) several hiking trails have been extended and will be available for interpretive purposes. Contact with local people through interpretive programs keeps the community informed of Park activities and provided information on a significant community resource. Park personnel are available to visit local organizations and present programs about the Park. In addition, Park staff will, upon invitation make presentations to school children and youth groups to enrich their knowledge of the Park and its story. Gros Morne also hosts many groups who make special arrangements to visit the Park. Several groups such as nature federations and birding groups have already made arrangements to visit the Park this summer.

6. Negotiations have begun with the Province of Newfoundland to determine the potential of the Avalon Peninsula as a corridor under the ARC Program. A joint planning process, including a joint planning team, has been outlined and discussed by both governments. Subject to the approval of the Government of Newfoundland, a joint feasibility study will be undertaken and should be completed within three months.
