REQUEST THAT REGALADO BRITO BE ADMITTED TO CANADA AS POLITICAL REFUGEE—MOTION UNDER S.O. 43

In view of a statement by the Minister of Employment and Immigration (Mr. Axworthy) that a country is judged on the way it treats its refugees, and considering the fact that the security certificate issued against Salvadoran refugee Regalado Brito deprives him of his fundamental rights, that only two federal ministers know the contents of the certificate, that the charges have never been proven and that this constitutes a travesty of justice, I move, seconded by the member for Beaches (Mr. Young):

That the House demand the withdrawal of the security certificate, the immediate release of Mr. Regalado and his admission into Canada as a political refugee.
