NEW 6 PER CENT TAX—GOVERNMENT POSITION

STATUS OF WOMEN

IMPACT OF PUBLIC SERVICE LAY-OFFS

Could the Minister explain why the Government has done nothing to assess the impact on women of its job cuts in the Public Service? Is it fair that most of these job cuts should be concentrated in the Public Service where wages are the lowest, therefore affecting job categories where the proportion of women is the highest?

Hon. Walter McLean (Minister of State (Immigration)): Mr. Speaker, I wish to thank the Hon. Member for posing what is a very sensitive and difficult issue. As Hon. Members know, the situation which was outlined by the President of the Treasury Board is a temporary one. The former Government Departments become tremendously unwieldy. I have been in touch with the President of the Treasury Board about the sensitivity in relation to these necessary actions.
