supervision from doctors, the nearest of whom may be located hundreds of miles distant, it is imperative that they be highly trained, not only in southern nursing practices techniques but also in fields such as diagnosis, drug prescription, X-ray interpretation, midwifery, and how to cope with emergencies of many kinds.

The nurse-practitioner program at the University of Alberta provided training in these needed skills, and nurses from remote areas learned much of great value to them and, as a result, saved many lives and reduced considerable suffering. It therefore comes as complete shock to find that Health and Welfare is discontinuing its support of the nurse-practitioner program. While the Liberal Government has millions of dollars to spend on imposing official bilingualism in the North, how, Sir, can it be so callous as to cut out the training programs for nurses who serve in an area where the infant mortality rate, for instance, is nearly double the national average?

REASSIGNMENT OF DEPUTY MINISTER

Perrin Beatty (Wellington-Dufferin-Simcoe): Mr. Speaker, yesterday we saw the disgraceful and cowardly spectacle of the Government sacking the Deputy Minister of National Revenue in the hope of distracting attention from the complete abdication of responsibility of the Minister. In view of the fact that the Minister of National Revenue refused pointedly on seven separate occasions in one day during Question Period in the House of Commons to back his Deputy Minister, will he deal honestly with Members of the House of Commons now and tell us in a straightforward way what was his recommendation to the Prime Minister? Did he recommend the transfer of his Deputy Minister?

Right Hon. P. E. Trudeau (Prime Minister): Mr. Speaker-

Some Hon. Members: Oh, oh!

Mr. Trudeau: Ho, ho, ho, ho! Ho, ho, ho! Where are they this morning?

Mr. Trudeau: Mr. Speaker, if the Hon. Member were sincere in his desire to stand up for the Deputy Minister and to show his respect for him, he would not have said that we have

sacked him. He knows that this is a way of showing his contempt for that man, and that is not our position.

Mr. Beatty: Mr. Speaker, on the strength of the Minister's performance to date, I can understand why the Prime Minister does not want to allow him to answer questions.

MINISTERIAL RESPONSIBILITY

Hon. Perrin Beatty (Wellington-Dufferin-Simcoe): Mr. Speaker, I would like to put my supplementary question to the Minister. We will see whether or not the Minister of National Revenue will attempt to hide and refuse to give answers to this question. In view of the repeated revelations over the course of the past several months that ordinary Canadians have suffered because of the Minister's gross neglect of his responsibilities, I would like to ask him what personal responsibility he feels that he carries as Minister for the conduct and activities of the officials of his Department. What personal responsibility does he have as Minister for the people whose rights have been taken away?
