PAYMENT AUTHORIZED TO FORMER INFORMANT

Hon. Bob Kaplan (York Centre): Mr. Speaker, I wish to ask the Solicitor General about the \$56,000 payment authorized by Order in Council to be made to Warren Hart, an FBI and RCMP informer. Why was this payment made when the McDonald Commission, as set out in volume 3 at page 497, found that his termination, his severance and departure from the RCMP had been properly handled? Will the Solicitor General tell the House what new facts came to the attention of the Government which justified the making of this additional payment?

Hon. James Kelleher (Solicitor General of Canada): Mr. Speaker, what we have here is another example of selective readings by the Hon. Member. I refer the Hon. Member to the conclusion of the report at page 500 which states that while in Canada for over four years Mr. Hart "performed laudable service for the people of Canada."

Some Hon. Members: Oh, oh!

Mr. Kelleher: As a result of that my predecessor ordered an internal independent inquiry to see whether or not he should be reimbursed for loss of services and expenses. This independent inquiry determined that he should be paid the amount of \$56,000. As a result of that recommendation payment was made.
