BOYD, Hon. John Gilmore, counsellor-at-law, is the s. of Alex. Boyd, by his wife, Elizabeth Gilmore. B. in Irel., 1840, he was brought to Can. when 4 yrs. of age, and received his early education at Huntingdon Acad., P. Q. He subsequently taught the dist. sch., and was Principal of Sherbrooke Acad. Entering McGill Univ. (B.A., 1861; M.A., 1864), he took also the law course at that institution (B.C.L., 1864), and was called to the bar. He practised his profession at Huntingdon, and from 1864 to 1868, was also ed. and prop. of the Journal published there in-the Lib.-Con. interest. In 1867 he unsuccessfully ran for the co. as a candidate for the Legislature. Mr. B. removed to N. Y., 1868, and, in the same year, was admitted to the

A Dem. in politics, he Bar Assn. was Chairman of the Tammany Hall Genl. Comte., and was elected enator in the 5th Senatorial Dist. of N.Y., 1881. He was one of the organizers of the original Anti-Monopoly League, and in the Senate was recognized as the leader in all antimonopoly legislation. He is now Presdt. of the National Citizens' Alliance, a lib. and independent political organization, and was favourably spoken of during 1896, as the logical candidate for gov. on a joint Democratic and People's party ticket. He was a public sch. trustee in the city of N. Y. for several yrs., and in addition to being a lawyer is a physician, having graduated M.D. from the Univ. of N. Y., 1874. He is a life mem. of the Am. Soc. for Prevention of Cruelty to Animals, a life mem. of the Am. Bible Soc., a Roval Arch Mason, a mem. of the German Liederkranz Soc. of N. Y., a mem. of the N. Y. Soc. of Med. Jurisprudence, and a mem of Soc. Française de l'Assn. des Unions Chrétiennes de Jeunes Gens de la Ville de N.Y. In religion, he is nonsectarian. He m. 1869, Miss Caroline E. Southwick, N.
