Order in Council, P.C. 383, dated February 14, 1936: respecting relief settlement in the province of Ontario under an agreement approved by Order in Council, P.C. 1112, dated May 28, 1934—list of eighty-two settlers in the province of Ontario who have been represented by the province as not being self-supporting at the expiration of the two year period and for whom subsistence expenditures during the third year of settlement is deemed necessary-Clause 3 of Agreement dated May 31, 1934.
